## CITY OF HAMILTON

### **BY-LAW NO. 09-106**

To Amend Zoning By-law No. 87-57 (Ancaster), respecting lands located at 402 Wilson Street East, in the former Town of Ancaster, now in the City of Hamilton

**WHEREAS** the <u>City of Hamilton Act, 1999</u>, Statues of Ontario, 1999 Chap.14, Sch. C. did incorporate, as of January 1<sup>st</sup>, 2001, the municipality "City of Hamilton";

**AND WHEREAS** the City of Hamilton is the successor to certain area municipalities, including the former area municipality known as "The Corporation of the Township of Ancaster" and is the successor of the former Regional Municipality, namely, "The Regional Municipality of Hamilton-Wentworth":

**AND WHEREAS** the <u>City of Hamilton Act, 1999</u>, provides that the Zoning By-laws and Official Plans of the former area municipalities and the Official Plan of the former regional municipality continue in force in the City of Hamilton until subsequently amended or repealed by the Council or the City of Hamilton;

**AND WHEREAS** Zoning By-law No. 87-57 (Ancaster) was enacted on the 22<sup>nd</sup> day of, June 1987, and approved by the Ontario Municipal Board on the 23rd day of January, 1989;

**AND WHEREAS** this By-law is in conformity with the Ancaster Official Plan, approved under the <u>Planning Act</u> by the Minister of Municipal Affairs and Housing on July 6, 1984.

**AND WHEREAS** the Council of the City of Hamilton, in adopting Section 31 of Report 06-005 of the Economic Development and Planning Committee, at its meeting held on the 12<sup>th</sup> day of April, 2006, recommended that the Director of Development and real Estate be authorized to give notice and prepare by-laws for presentation to Council, to remove the "H" Holding provision from By-laws where the conditions have been met;

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

- 1. That Map 2 to Schedule "B", appended to and forming part of By-law No. 87-57 (Ancaster), as amended, is hereby amended:
  - (a) by changing the zoning of Block 1 from the Village Area "VA-502(H)" Holding Zone, Modified to the Village Area "VA-502" Zone, Modified.
- 2. All other regulations of the Village Area "VA-502" Zone, Modified, as amended and any other General Provision of Zoning By-law No. 87-57 (Ancaster), shall continue to apply.
- 3. The Clerk is hereby authorized and directed to proceed with the giving of notice of the passing of this By-law, in accordance with the <u>Planning Act</u>.


