

CITY OF HAMILTON

BY-LAW NO. 04- 076

**To Amend By-law No. 01-218, as amended,
Being a By-law To Regulate On-Street Parking**

WHEREAS Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating traffic on highways subject to the Highway Traffic Act;

AND WHEREAS Section 314(7) of the Municipal Act confers upon councils of all municipalities the power to enact by-laws to provide for placing, regulating and maintaining upon the public highways traffic signs for the purpose of guiding and directing traffic;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"Mountwood East Freeman to St. Joseph's 1 hr Anytime Anyday"

2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Limeridge Both Ridge to Kingfisher Anytime

Limeridge North Kingfisher to easterly end Anytime"

and by adding to Section "E" thereof the following items, namely:

"Bonaparte South Brigade to 25m easterly Anytime

Bonaparte South from 25m east of Brigade to 8:00 a.m. to 4:00 p.m.
189.9m easterly Monday to Friday

3. Schedule 10 (Alternate Side Parking) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "C" thereof the following item, namely:

“Bronte Court Howland Mills Drive to westerly end South North”

4. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

5. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:


and by adding to Section "E" thereof the following items, namely:

| Bonaparte | North | Corsica to 19m westerly | Anytime |
| Bonaparte | North | Corsica to 17.5m easterly | Anytime |
| Bonaparte | North | Fusilier to 19m westerly | Anytime |
| Bonaparte | North | Fusilier to 18.9m easterly | Anytime" |

6. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
7. This By-law shall come into force and take effect on the date of its passing and enactment.
