## CITY OF HAMILTON

**BY-LAW NO. 05- 011** 

## To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

**WHEREAS** Section 11(1)1 of the <u>Municipal Act</u>, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the <u>Highway Traffic Act</u>;

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Barton North from 34.5m west of East Avenue to 6.2m Anytime" westerly

2. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Strathearne West from 125.6m south of Barton to 7.9m Anytime" southerly

and by adding to Section "E" thereof the following item, namely:

"Albert West from 78.6m north of Maplewood to 6.4m Anytime"

3. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "A" thereof the following item, namely:

"Trinity Rd. East Wilson St. W. to 113.7m southerly Anytime"

and by adding to Section "E" thereof the following items, namely:

"Charlton North Ferguson to 43.9m westerly Anytime

Charlton North from 53.7m west of Ferguson to Walnut Anytime

Charlton South Walnut to Ferguson Anytime

Charlton Both End to End Anytime Ramp

Charlton Both Wellington to Wentworth Anytime

Charlton South John to 38.1m westerly Anytime

Charlton North Park to 27.4m easterly Anytime"

and by deleting from Section "G" thereof the following items, namely:

"Charlton Both Walnut to Ferguson Anytime

Charlton Both End to End Anytime

Ave. Ramp

Charlton Both Wellington to Wentworth Anytime

Charlton South John to 125 ft. west Anytime

Charlton North Park to 90 feet east Anytime"

4. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"Charlton North from 43.9m west of Ferguson to 9.8m Anytime"

- 5. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
- 6. This By-law shall come into force and take effect on the date of its passing and enactment.
