CTTY OF HAMILTON BY-LAW NO. 05-172 To Amend By-law No. 01-215 Being a By-law To Regulate Traffic

WHEREAS Section 11(1)1 of the <u>Municipal Act</u>, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the <u>Highway Traffic Act</u>;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-215 to regulate traffic;

AND WHEREAS it is necessary to amend By-law No. 01-215.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

- 1. Section 1 of By-law 01-215, as amended, is hereby further amended by deleting subsection (y) in its entirety, and by substituting in its place the following subsection, namely:
 - "(y) "School Zone" means an area through which a highway or part highway passes, which is in proximity to a school where the speed limit on said highway or part highway is reduced;"
- 2. By-law 01-215, as amended, is hereby further amended by deleting Section 8 therefrom, in its entirety, and by substituting in its place the following Section, namely:

"SCHOOLZONES - REDUCED SPEED LIMITS

- 8. (1) A reduced speed limit for motor vehicles is hereby prescribed for those highways or parts of highways which are listed in Schedule 3.
 - (2) Schedule 3 describes the following:

- in column one thereof, the name of the highway or part highway designated as a School Zone and upon which the reduced speed limit is in force and effect;
- (b) in column two thereof, the limits between which the reduced speed limit is in force and effect;
- (c) in column three thereof, the reduced speed limit in km/h which is in force and effect:
- (d) In column four thereof, the times and days in which the reduced speed limit is in force and effect."
- 3. Schedule 3 (Flashing School Zones Reduced Speed Limit) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "B" thereof the following item, namely:

"Governor's from 18m west of Old Governor's 40 8:25 a.m. to 9:25 a.m." (East Leg) to 79m east of Old 3:10 p.m. to 4:10 p.m. Governor's Road (West Leg)

and by adding to Section "D" thereof the following item, namely:

"Highway from 361m north of Cemetery 50 8:00 a.m. to 9:00 a.m."
No. 56 to 115m south of Guyatt 2:35 p.m. to 3:35 p.m.

and by adding to Section "E" thereof the following item, namely:

"Charlton from 50m west of Aurora to 40 8:20 a.m. to 4:00p.m."

107m east of Catharine

and by adding to Section "F" thereof the following item, namely:

"Barton	from 35m west of Hilton to 63m east of Green	40	8:20 a.m. to 9:20 a.m. 2:55 p.m. to 3:55 p.m.
Dewitt	from 45m north of Highway No.	40	8:00 a.m. to 9:00 a.m. 10:40 a.m. to 12:30 p.m. 2:05 p.m. to 3:05 p.m.
	8 to 50m south of Cresthaven		
Dewitt	from 33m north of Cresthaven to 59m north of Dupont	40	8:10 a.m. to 9:10 a.m." 11:20 a.m. to 1:15 p.m. 2:45 p.m. to 3:45 p.m.

- **4.** Subject to the amendments made in this By-law, in all other respects, By-law No. 01-215, including all Schedules thereto, as amended, is hereby confirmed unchanged.
- 5. This By-law shall come into force and take effect on the date of its passing and enactment.
