BY-LAW NO. 05-298

To Amend Bylaw No. 01-218, as amended, Being a Bylaw To Regulate On-Street Parking

WHEREAS Section 11(1)1 of the <u>Municipal Act</u>, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the <u>Highway Traffic Act</u>;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Barton North Walter to Adeline 2hr 6 pm - 11 pm Mon-Sat"

2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "B" thereof the following item, namely:

"Cross East Park to 23.5m southerly Anytime"

and by deleting from Section "E" thereof the following items, namely:

Barton North Strathearne to Walter Anytime

Barton North Adeline to Parkdale Anytime"

and by adding to Section "E" thereof the following item, namely:

"Barton North Strathearne to Parkdale Anytime"

and by deleting from Section "G" thereof the following item, namely:

"Barton North Walter to Adeline 7:00 am - 6:00 pm"

3. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

| "Britannia | South | from 26.5m west of Park Row to 6.1m westerly | Anytime |
