CITY OF HAMILTON

BY-LAW NO. 06-101

To Amend By-law No. 01-218, Being a By-law To Regulate On-Street Parking

WHEREAS the Council of the City of Hamilton has determined that it is appropriate to amend City of Hamilton By-law No. 01-218, as amended, such that parking fees will no longer be imposed for parking at on-street parking meters on Saturdays within the Community Improvement Plan area of the City;

AND WHEREAS Section 11(1)1 of the Municipal Act 2001, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the Highway Traffic Act;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate On-street Parking;

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

- 1, By-law No. 01-218, as amended, is hereby further amended by deleting paragraph (a), in its entirety, from subsection 8(3) thereof and substituting in its place the following paragraph, namely;
 - "(a) Provisions requiring payment of parking fees and prohibitions against using a parking space while no unexpired "paid for" time is indicated on the parking meter adjacent to said space, shall apply only during the days and times indicated on a sign affixed to the parking meter."
- 2, By-law No. 01-218, as amended, is hereby further amended by deleting paragraph (b), in its entirety, from subsection 8(3) thereof and substituting in its place the following paragraph, namely;
 - "(b) Provisions prohibiting parking in a parking space normally regulated by a parking meter, for a period of time greater than the parking time limit indicated on the adjacent parking meter shall apply only during the days and times indicated on the subject parking meter."

- 3, By-law No. 01-218, as amended, is hereby further amended by deleting paragraph (a), in its entirety, from subsection 8(5) thereof and substituting in its place the following paragraph, namely;
 - "(a) No person shall park a vehicle at any parking space for a period of time greater than the parking time limit indicated by a sign, either affixed to the parking meter adjacent to the parking space or otherwise posted in proximity to the parking space, or, where the adjacent parking meter has been removed, for a period of time greater that the parking time limit indicated by a sign affixed to the parking meter adjacent to an adjoining parking space or otherwise posted in proximity to said adjoining parking space."
- 4, By-law No. 01-218, as amended, is hereby further amended by deleting paragraph (c), in its entirety, from subsection 8(5) thereof and substituting in its place the following paragraph, namely;
 - "(c) No person shall park a vehicle or leave a vehicle parked at any parking space, at any time during the days and times posted on the adjacent parking meter indicating when the parking meter regulations are in force and effect, when there is no unexpired "paid-for" time indicated on the subject parking meter, save and except that this provision shall not be deemed to apply when it is shown that the parking meter is out of order."
- 5. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, as amended, including all Schedules thereto, is hereby confirmed unchanged.
- 6. This By-law shall come into force and take effect on the date of its passing and enactment.
