CITY OF HAMILTON

BY-LAW NO. 07-243

BEING A BY-LAW TO APPOINT MUNICIPAL LAW ENFORCEMENT OFFICERS FOR THE CITY OF HAMILTON

WHEREAS Section 15(1) of the Police Services Act R.S.O. 1990, c.P.15 authorizes the Council of any municipality to appoint one or more Municipal Law Enforcement Officers, who shall be peace officers for the purposes of enforcing the by-laws of the municipality;

AND WHEREAS Section 207(45) of the Municipal Act R.S.O. 1990, c.M.45, authorizes the Council of any municipality to appoint certain officers or such officers and employees as may be necessary for the purposes of the corporation, or for carrying into effect any Act or Legislature or by-law of the Council, and for fixing their remuneration and prescribing their duties, and the security to be given for the performance of them;

AND WHEREAS Section 210(46) of the Municipal Act R.S.O. 1990, c.M.45, provides that local municipalities may pass by-laws to authorize appointed officers to enter property to ascertain whether the by-law is obeyed and to enforce and carry into effect the by-law;


AND WHEREAS it is deemed expedient to appoint Municipal Law Enforcement Officers;

NOW THEREFORE, the Council of the City of Hamilton enacts as follows:

1. That the persons set out in Schedule "A" of this by-law are hereby appointed as Municipal Law Enforcement Officers for the City of Hamilton, for the purpose of exercising all the powers and performing all the duties of a Municipal Law Enforcement Officer in the enforcement of the by-laws of the City of Hamilton;
2. That the City officers whose names appear in Schedule "A" of the by-law are hereby authorized at all reasonable times to enter on any property in the City to ascertain whether a city by-law is complied with, and to enforce or carry into effect any city by-law respecting the property of the occupants thereof;

3. That the following by-laws are hereby repealed: By-law 08-084 and By-law 01-068
4. This By-law shall come into force and effect on the date of its passing and enactment.
