CITY OF HAMILTON

BY-LAW NO. 09-084

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the Highway Traffic Act;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "A" thereof the following item, namely:

"Londonderry Both Lowinger to east end 2 hr 8 am – 5 pm Mon – Fri"
of Londonderry

2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "A" thereof the following item, namely:

"Londonderry Both Lowinger to east end of 7:00 a.m. – 4:30 p.m."
Londonderry Monday to Friday

and by deleting from Section "E" thereof the following item, namely:

"Coronation Both Parkdale to easterly end 8:30 am – 5 pm"
Mon - Fri

and by adding to Section "E" thereof the following items, namely:

"Coronation South Parkdale to easterly end 8:30 a.m. to 5:00 p.m."
Monday to Friday

To Amend By-law No. 01-218, as amended,

Emerson East Ainslie to southerly end of Dec 1st to Mar 31st²
Emerson

3. Schedule 9 (Alternate Side Parking) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "C" thereof the following item, namely:

"Vance Pamela to Boulding North South"

4. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Emerald East from 70m south of Barton to 6.5m Anytime"
southerly

and by adding to Section "E" thereof the following items, namely:

"Emerald East from 75.6m south of Barton to 5.5m Anytime
southerly


Emerald East from 70m south of Barton to 5.6m Anytime
southerly

Inchbury East from 8.5m north of the extended Anytime
north curb line of Kinnell to 5.2m
northerly

Land North from 13.1m west of Niagara to 5.3m Anytime"
westerly

5. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
6. This By-law shall come into force and take effect on the date of its passing and enactment.
