BY-LAW NO. 09-257

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the Highway Traffic Act;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

Birch (west leg)	West	Barton to 290 feet south	7 am – 6 pm Mon - Sat
Emerald	West	Barton to Robert	Anytime"

and by adding to Section "E" thereof the following items, namely:

"Amore	South	from 43.7m east of Upper Paradise to 6m easterly	Anytime
Emerald	West	Barton to Cannon	Anytime"

2. Schedule 10 (Alternate Side Parking) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Emerald Cannon Street East to Robert East West"

3. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Land North from 24.9m east of Wentworth to 5.8m Anytime" easterly

and by adding to Section "E" thereof the following items, namely:

"Fairleigh	West	from 90.1m south of Wilson to 5.7m southerly	Anytime
Hazell	East	from 64.9m north of Wilson to 5.8m northerly	Anytime
Stirton	West	from 34.7m north of King to 5m northerly	Anytime
Stirton	East	from 39.6m north of King to 5m northerly	Anytime"

4. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "A" thereof the following item, namely:

Boundary to 350m southwesterly

and by deleting from Section "E" thereof the following item, namely:

"Locke West from 18.3m south of Chatham Anytime" to 6.4m southerly

5. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Ivon

West

Britannia to 12.2m southerly

6. Schedule 20 (School Bus Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"London

East

from 22m north of King to

7:00 a.m. to 4:00 p.m."

52.6m northerly

Monday to Friday
