BY-LAW NO. 12-050

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Pearl 2 hr Anyday" East King to Napier Anytime and by adding to Section "E" thereof the following items, namely:

"Pearl King to 19.8m south 1 hr 8 am - 6 pm Mon – Fri East of Napier

2 hr Anytime Anyday" Pearl East Napier to 19.8m southerly

2. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "A" thereof the following items, namely:

South "Tomahawk from 60.3m east of McNiven to & West 39.4m easterly and southerly along the curbline

and by deleting from Section "E" thereof the following items, namely:

and by adding to Section "E" thereof the following item, namely:

"Purnell East & from 124.8m south of the east Anytime"

3. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

"Avondale West from 69.8m south of Barton to 8.8m Anytime" southerly
and by adding to Section "E" thereof the following items, namely:

"Avondale West from 69.8m south of Barton to 6.2m Anytime southerly Avondale West from 76m south of Barton to 6.2m **Anytime** southerly Avondale East from 75.8m south of Barton to 6m Anytime southerly from 65.8m north of the extended Sanford East Anytime" north curb line of Rutherford to 7m northerly

4. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:
