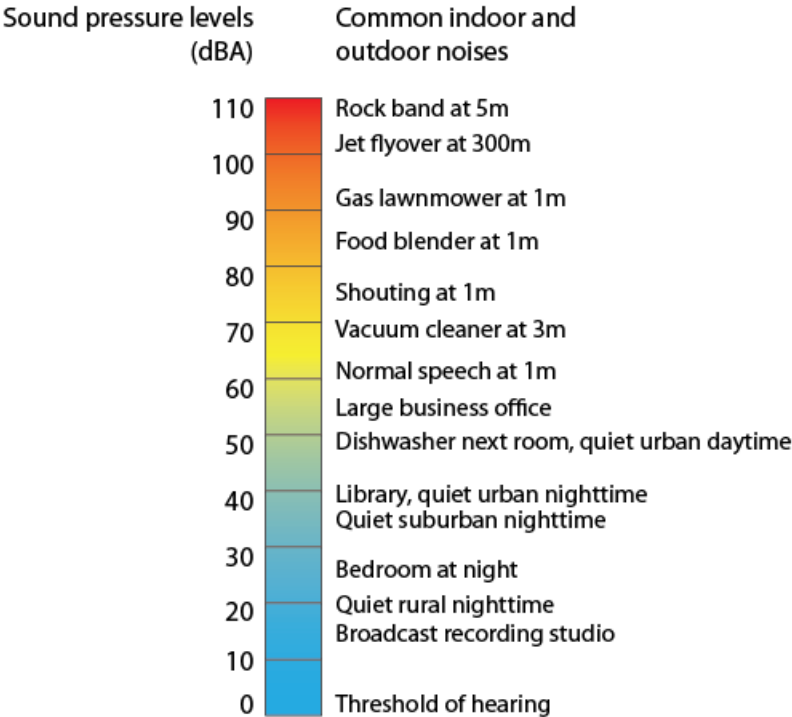

Personal information contained in this application is collected pursuant to the City of Hamilton's Noise By-law 11-285 and will be used for the administration and enforcement of this by-law. Questions regarding the collection of this information may be addressed to the By-law Clerk at 905-546-2782 option 2.

Noise Exemption Permits may be issued with the following restrictions:

- a. any noise does not exceed 90 dBA as measured 10 m from its source;
- b. any noise does not exceed 60 dBA at a point of reception;



When considering the issuance of a permit the City will take into consideration:

- a. any negative effects the issuance of the exemption permit may have on neighbouring properties or on the City;
- b. any benefits the issuance of the exemption permit may have on neighbouring properties or on the City;
- c. any previous violations of this By-law or an exemption permit by the applicant

The City may impose certain conditions such as:

- a. the type and volume of the noise that may be made;
- b. the times during which noise may be made;
- c. the period of time during which the exemption permit is in effect;

If the applicant is found in contravention of any conditions in the Exemption Permit, the permit may be rescinded.
