CITY OF HAMILTON

BY-LAW NO. 14- 015

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS *Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25*, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "D" thereof the following items, namely:

"Binbrook Road	South	Regional Road 56 to 304.8m westerly	Anytime
----------------	-------	-------------------------------------	---------

Binbrook Road	South	From 195.1m east of Regional Road 56 to 94.1m easterly	Anytime"

and by adding to Section "D" thereof the following items, namely:

"Binbrook	Both	Regional Road 56 to Royal Winter/Binhaven	Anytime

Binbrook	South	from 195.1m east of Regional Road 56 to 94.1m easterly	Anytime"
----------	-------	--	----------

and by deleting from Section "E" thereof the following item, namely:

"Greenhill	East	Vidal to T.H.&B. Tracks	Anytime"
------------	------	-------------------------	----------

and by adding to Section "E" thereof the following items, namely:

"Beaucort	North	Mericourt to westerly end of Beaucort	December 1 st to March 31 st
Greenhill	East	from 114.5m south Vidal to T.H.&B. Tracks	Anytime"

3. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Cumberland	North	from 31.6m west of Lorne to 6m westerly	Anytime
Ferrie	South	from 11.6m west of MacNab to 6.4m westerly	Anytime
Napier	South	from 38.4m west of Wellsley to 6m westerly	Anytime"

and by adding to Section "E" thereof the following items, namely:

"Edgar	East	from 20.3m south of Argyle to 6m southerly	Anytime
Edgar	West	from 25.6m south of Argyle to 6.7m southerly	Anytime
Grant	East	from 31m south of Stinson to Alanson	Anytime
Napier	South	from 38.4m west of Wellesley to 6m westerly	Anytime
Park Row	East	from 25m north of Dunsmure to 6.4m northerly	Anytime"

4. Schedule 13 (No Stopping Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following items, namely:

"Greenhill	East	Vidal to 20m southerly	Anytime
------------	------	------------------------	---------

Sanatorium West Redfern to 60m southerly Anytime"

and by deleting from Section "F" thereof the following items, namely:

"President Both From the east curb of the west Anytime
Drive (South leg of President Drive to a
Leg) point 23m east

President Both From the north curb of the Anytime"
Drive (West south leg of President Drive to
Leg) a point 23m north

and by adding to Section "F" thereof the following item, namely:


"President North from 52m west of Farmingdale Anytime"
& East to 31m westerly and northerly
along the curb line

5. Schedule 14 (Wheelchair Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by adding to Section "E" thereof the following item, namely:

"Cambridge South from 82.7m east of Frederick Anytime"
to 6.6m easterly

8. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
9. This By-law shall come into force and take effect on the date of its passing and enactment.
