CITY OF HAMILTON

BY-LAW NO. 14-024

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS Section 11(1)1 of the *Municipal Act, S.O. 2001, Chapter 25*, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 8 (No Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Limeridge	South	Birchview to Mountain Brow	Anytime
Roxborough	South	From Graham to 134 ft. westerly	7 am – 6 pm" Mon - Sat

and by adding to Section "E" thereof the following items, namely:

"Balsam	East	from 18.8m south of Barton to 20.7m southerly	Anytime
Limeridge	South	from 133.9m west of Upper Ottawa to Mountain Brow	"Anytime"

and by adding to Section "F" thereof the following item, namely:

"Highgate	East	from 23.7m north of the northern intersection with Bankfield to 53.9m northerly and easterly along the curbline	Anytime"

and by adding to Section "G" (Loading Zones) thereof the following item, namely:

"Haddon	East	from 42.2m north of King to 11m northerly	Anytime"

2. Schedule 12 (Permit Parking Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:


and by adding to Section "E" thereof the following items, namely:

"Catharine	West	from 37.3m south of Picton to 6m southerly	9:00 a.m. to 5:00 p.m. Monday to Saturday
East	East	from 89m north of Robert to 8.5m northerly	8:00 a.m. to 4:00 p.m." Monday to Friday

5. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.

6. This By-law shall come into force and take effect on the date of its passing and enactment.
