BY-LAW NO. 16-018

To Amend By-law No. 01-218, as amended, Being a By-law To Regulate On-Street Parking

WHEREAS *Section 11(1)1 of the Municipal Act, S.O. 2001, Chapter 25*, as amended, confers upon the councils of all municipalities the power to enact by-laws for regulating parking and traffic on highways subject to the *Highway Traffic Act*;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-218 to regulate on-street parking;

AND WHEREAS it is necessary to amend By-law No. 01-218, as amended.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 6 (Time Limit Parking) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following items, namely:

"Tom	North	commencing 173 feet west of Strathcona and extending to Dundurn	1 hr	8 am – 5 pm	Mon – Fri
Tom	South	Strathcona to Dundurn	1 hr	8 am – 5 pm	Mon – Fri"

and by adding to Section "E" thereof the following items, namely:

"Tom	North	from 52.7m west of Strathcona to Devonport	1 hr	8 am – 5 pm	Mon – Fri
Tom	South	Strathcona to Devonport	1 hr	8 am – 5 pm	Mon – Fri"

"Binkley Rd Main to Sanders East West"

6. Schedule 15 (Commercial Vehicle Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

“Conession North from 33.4m west of East 17th to 5.7m westerly Anytime”

7. Schedule 20 (School Bus Loading Zones) of By-law No. 01-218, as amended, is hereby further amended by deleting from Section "E" thereof the following item, namely:

“Maplewood	North	75 feet	118 feet west of Springer	7:00 a.m. to 6:00 p.m.” Monday to Saturday

and by adding to Section "E" thereof the following item, namely:

9.4m westerly Monday to Saturday

and by deleting from Section "F" thereof the following item, namely:

“Barton Street North From 153.4m east of Green 7:00 a.m. to 6:00 p.m.”
Road to 95.1m easterly Monday to Saturday

8. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-218, including all Schedules thereto, as amended, is hereby confirmed unchanged.
9. This By-law shall come into force and take effect on the date of its passing and enactment.
