CLASS ENVIRONMENTAL ASSESSMENT STUDY ANCASTER ELEVATED WATER RESERVOIR

Project Background

The City of Hamilton is planning to construct an elevated water reservoir to provide floating storage for the Pressure District 18 in Ancaster. The City has initiated a Schedule B Class Environmental Assessment (Class EA) study for this project in accordance to the *Municipal Class Environmental Assessment* document (October 2000, as amended in October 2007, 2011 and 2015). The need for an elevated water reservoir was documented in the City of Hamilton's Water and Wastewater Master Plan Class Environmental Assessment Report (November 2006), which indicated an unbalanced water supply and limited ability to adequately service system demands in the area.

The Study Process

The purpose of this Class EA study is to determine the preferred location to construct an elevated water reservoir within the study area (see Figure).

Consultation with, and input from the public and government review agencies will be a vital component of the Class EA study. Members of the public and review agencies are invited to provide comment for incorporation into the overall planning and design of the Ancaster Elevated Water Reservoir. Additional notices will be advertised to inform, and to solicit further input from the public as the study progresses.
