#### Weekly Action Tracker

The Weekly Action Tracker includes all complaints and service requests received by Housing Focused Street Outreach (HFSO) regarding potential encampments that are new and/or in need of a Protocol compliance assessment. Ocassionally, after a site has been designated by staff as cleared, different individual(s) may move inot the same location and erect a new tent. To maintain clarity and ensure individuals are given an opportunity to be informed of the Encampment Protocol, any time new tents are discovered in an area that has been previously cleared, the process will restart with HFSO attending to engage. All sites that have previously met compliance will be identified as a 'new' site when a tent begins to occupy a non-compliant space, with the exception of previously escalated sites on private property. Once a private property owner has been notified of the process, they become responsible for contacting the appropriate enforcement body.
