City of Hamilton Civic Golf Courses | Terms and Conditions of Season Pass

1. Nature of Annual Season Pass:

A season pass holder confers a limited license to use the designated City of Hamilton ("Course") to which it relates, as provided in and subject to the Rules and Regulations as set by the City in its discretion, as amended form time to time. A Season pass does not confer on its holder or carry with it any interest in the property or assets of the Course, or any right to participate in the management of the Course. The season pass is for regular play and pass holder events only and does not include entry fees or green fees for outside tournaments and events. The City reserves the right in its sole discretion to place limits on the number of season pass holders it permits on the Course or in any category of type of membership, from time to time.

2. Renewal, Suspension, Termination and Transferability of Memberships:

Renewal of Season Pass Holders – All season passes have an annual term and run continuously from a predetermined date of opening each year, or the date of acceptance of a season pass holder's application, to the end of the season weather permitting at the discretion of Golf Operations Management.

<u>Termination of Season Pass Holders</u> – The City reserves the right at any time to terminate the season pass holders privileges there under for failure to comply with any of the Rules and Regulations of the Course or for any conduct which the City determines to be detrimental violence on City sports and recreational facilities. A season pass may be terminated by notification in writing mailed by the City to the last address shown on the records of the City for the season pass holder whose season pass is being terminated. The terminated season pass holder will be required to return promptly his or her season pass card to the City.

<u>Suspension of Season Pass Holders by the City</u> – The City (either directly or through the Course Management) reserves the right at its sole discretion and option to suspend at any time or times and for any period of the season pass of any season pass holder and any and all parties associated with such parties for:

- a) Behaviour or activities in, about, or in respect to the Course which are not acceptable to the City or the management of the Course, in the sole and unfettered discretion of the City or Course management, as the case may be; and
- b) Failure to observe and comply with all Course Rules and Regulations and Policies and Procedures including dress code violations and beer and alcohol violations.
- c) Failure to obtain a daily starters ticket for play.

The City also reserves unto itself any and all rights and remedies to which it may be entitled at common law, statute or otherwise. Termination of Season Pass by Season Pass Holder - A season pass holder may terminate his or her season pass at any time for medical reasons by delivery of written notice accompanied by a valid doctor's note to the management of the Course to which it relates along with the return of his or her season pass card (if applicable). Refunds, prorated discounts or rebates will be at the sole discretion of the City.

<u>Transferability of Season Pass</u> – All rights and benefits arising under a season pass is for the exclusive use of the season pass holder and is not transferable or assignable.

3. Waiver of Claims & Indemnity:

It is expressly agreed that all use of the Course facilities, participation in programs, classes and activities and any transportation provided by the City shall be at the sole risk of all season pass holders. The City shall not be liable to any season pass holder for any claim, demand, injury or damages to any season pass holder, to the property of any season pass holder damaged, lost or stolen in or about the Course including but not limited to automobiles and contents thereof whether or not resulting from acts of active passive negligence on the part of the Course, its management, the City of Hamilton, or its elected officials, officers, employees, or agents. Each season pass holder, for himself/herself and on behalf of his/her executors, administrators, heirs, assigns, and successors, has in the Season Pass Application Form hereby confirms that they have expressly released and discharged the Course management, the City of Hamilton, its elected officials, officers, employees, agents, assigns and successors form all such claims demands, injuries, damages, actions or causes of action which the season pass holder may have arising out of his/her season pass as a result of:

- a) any loss of, or theft of, or damages to the personal property of the season pass holder, occurring in or about the premises of the Course whether or not such loss, theft, or damage results for acts of active or passive negligence on the part of the Course, its owners, directors, officers, employees, agents assigns or successors; or
- b) any illness, accident, death, injury or deterioration in health sustained by the season pass holder, in, on or about the premises by the Course or as a result of or in consequence of the programs followed by the season pass holder upon the recommendation of the Course management or golf professional associated with a course, or an activity in which the season pass holder engages in the course of his or her season pass at the Course.

Each season pass holder also agrees to indemnify and save harmless the Course management and the City of Hamilton, its elected officials, officers, employees, agents, assigns, and successors from any such claims, demands, action or causes of action which any one or more of the foregoing may have or incur as a result of any conduct, act or omission on the part of a season pass holder, or anyone else for whom he or she is legally responsible, whether intentional, negligent or otherwise.

Each season pass holder warrants that he/she has no disability, impairment or ailment which could prevent him or her from engaging in active exercise of the nature contemplated by the season pass category or categories which such season pass holder has joined. If a season pass holder suffers a minor injury limited assistance is available. Each season pass holder or guest is responsible for ensuring that any injury they suffer receives proper medical attention. Please report injury to the Course Management immediately.
